Those traveling on our multi-use pathway are reminded that while "Share the Road" signs on highways are primarily informing *drivers* that it is their responsibility to give cyclists room to drive safely on the road, our CYCLISTS signs are notifying *cyclists* of their responsibility.



When a cyclist travels on our walkway, the posted ordinance requires that an audible sound be made before passing a pedestrian. Given that our &mmunity has a predominantly senior population with an attendant fairly high number of people with some degree of hearing loss, common sense would dictate a fairly loud (short) sound as well as the practice of passing on the left as is the custom on the roads.
